Dog Control Issues – consider complaints and possible measures to remedy the situation – current method of dog control. Notes from 2021...(excerpted from a memo provided to Council by Ms. Mia Carella, Lawyer with Wishart Law of Sault Ste. Marie, Ontario) "The biggest issue is that if someone does not comply with a letter sent by Cockburn Island, without a means of enforcement, it is difficult to enforce a requirement if there is no recourse.

For example, if you're going to enforce an animal control by-law and send out warnings for non-compliance, at some point you will have to charge the individual under the by-law. This presents another problem. I further understand that by-law enforcement and policing is not present therefore making it even more difficult to enforce a by-law or community rules related to dogs."
